### SUPPLEMENTARY APPROPRIATION BILL, 2019

#### **GRENADA**

#### ACT NO. OF 2019

**AN ACT** to appropriate an additional sum of Nine Million, Nine Hundred and Sixty-Seven Thousand, Seven Hundred and Ninety Dollars (\$9,967,790.00) to service of the State of Grenada for the period August 1<sup>st</sup> to December 31<sup>st</sup>, 2019.

**BE IT ENACTED** by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

#### **Short title**

1. This Act may be cited as the

#### SUPPLEMENTARY APPROPRIATION ACT, 2019.

### **Appropriation**

- 2. (1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the period August 1<sup>st</sup>, to December 31<sup>st</sup>, 2019, a sum not exceeding Nine Million, Nine Hundred and Sixty-Seven Thousand, Seven Hundred and Ninety Dollars (\$9,967,790.00) in addition to the sums already appropriated for that year.
- (2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
