STATUTORY RULES AND ORDERS NO. 34 OF 2021

IN EXERCISE OF THE POWERS CONFERRED UNDER SECTION 4 OF THE EMERGENCY POWERS ACT, CHAPTER 88 FOR THE PURPOSES OF SECTION 17 OF THE CONSTITUTION, THE CABINET OF GRENADA MAKES THE FOLLOWING REGULATIONS—

(Gazetted 20th August, 2021).

**1. Citation.** These Regulations may be cited as the

EMERGENCY POWERS (COVID-19) (AMENDMENT) (NO. 5)  
REGULATIONS, 2021,

and shall be read as one with the Emergency Powers (COVID-19) Regulations, 2021, SRO No. 3 of 2021 hereinafter referred to as the “principal Regulations”.

**2. Amendment of regulation 3 of principal Regulations.**—(1) Regulation 3 of the principal Regulations is amended as follows—

- (a) in sub-regulation (1) by deleting the words “Beginning at 12:00 a.m. on the 18th day of February, 2021 a curfew shall be imposed daily from 12:00 a.m. and ending at 4:00 a.m.” before the words “and during this period” and substituting therefor the words “Beginning at 9:00 p.m. on the 21st day of August, 2021 a curfew shall be imposed daily from 9:00 p.m. and ending at 5:00 a.m.”;
- (b) in sub-regulation (2) by deleting the numbers “4:00 a.m. to 11:59 p.m.” before the words “each day” and substituting therefor the numbers “5:00 a.m. to 8:59 p.m.”.

(2) For the avoidance of doubt, there remains in effect a curfew from 12:00 a.m. and ending 4:00 a.m. on the 21st day of August, 2021.

**3. Amendment of regulation 6 of principal Regulations.** Regulation 6 of the principal Regulations is amended as follows—

- (a) in sub-regulation (1) by deleting the words “of the Minister” after the words “by Order” and substituting therefor the words “by the Cabinet”;
- (b) by repealing sub-regulation (2);

(c) by inserting after sub-regulation (8) the following new sub-regulations—

“(9) Any approval granted under sub-regulation (7) is hereby suspended for the period from the 21st day of August, 2021 to the 3rd day of September, 2021.

(10) Notwithstanding sub-regulation (1) and any approval granted under these Regulations but without prejudice to sub-regulation (6), for the period from the 21st day of August, 2021 to the 3rd day of September, 2021—

- (a) no business, establishment, office, institution or person shall host or facilitate any party-like activity including but not limited to bus tours, private parties, beach parties and other forms of public entertainment; and
- (b) no business, establishment, office, institution or person shall play amplified music or host live entertainment.”.

**4. Amendment of regulation 7 of principal Regulations.** Regulation 7 of the principal Regulations is amended as follows—

(a) by inserting after sub-regulation (1) the following new sub-regulation—

“(1A) In respect of an event or gathering permitted under sub-regulation (1) and scheduled for a date during the period from the 21st day of August, 2021 to the 3rd day of September, 2021—

- (a) there shall be no party-like activity including but not limited to bus tours, private parties, and beach parties; and
- (b) no amplified music shall be played.”;

(b) by inserting after sub-regulation (4) the following new sub-regulation—

(5) Every approval granted under sub-regulation (2) or (3) in respect of an event or gathering scheduled for a date during the period from the 21st day of August, 2021 to the 3rd day of September, 2021 is hereby revoked.”.

**5. Amendment of regulation 15 of principal Regulations.** Regulation 15 of the principal Regulations is amended as follows—

- (a) in sub-regulation (1), by deleting the number “3 (1)” after the word “regulation” and substituting therefor the number “14 (1)”;
- (b) in sub-regulation (4), by deleting the numbers “4 to 8” after the word “regulations” wherever this appears and substituting therefor the numbers “15 to 19”;
- (c) in sub-regulation (5), by deleting the number “3 (2)” after the word “regulation” and substituting therefor the number “14 (2)”;
- (d) in sub-regulation (6), by deleting the number “6 (2)” after the word “regulation” and substituting therefor the number “17 (2)”;
- (e) in sub-regulation (7) (d), by deleting the number “6 (2)” after the word “regulation” and substituting therefor the number “17 (2)”.

**6. Amendment of regulation 18 of principal Regulations.** Regulation 18 of the principal Regulations is amended by deleting the number “3 (2)” after the word “regulation” and substituting therefor the number “14 (2)”.

**7. Amendment of regulation 19 of principal Regulations.** Regulation 19 of the principal Regulations is amended by deleting the number “6 (2)” after the word “regulation” and substituting therefor the number “17 (2)”.
