
The Consumer Price Index moved from 118.26 index points in the month of April 2023 to 118.34 index points in May 2023, recording an increase of 0.07%. The table above displays the Index for the months of April 2023, May 2023, and the corresponding months of the last two years: May 2021 and 2022, for comparison.

Increase in the following groupings, resulted in the upward movement of the Index: "Food and Non-Alcoholic Beverages" (0.55%), "Alcoholic Beverages and Tobacco" (0.65%), "Furnishing, Household Equipment and Routine Household Maintenance" (0.33%) and "Miscellaneous Goods and Services" (0.16%). These increases were as a result of a rise in prices of: Rice (0.04%), Breakfast Cereal (0.28%), Pasta Products (0.53%), Pork (2.56%), Mutton (5.45%), Poultry Meat (0.80%), Deli Meat (0.08%), Fresh Fish (2.34%), Preserved Fish (0.36%), Milk (0.11%), Cheese (0.54%), Eggs (1.08%), Preserved Fruits (0.17%), Potatoes (0.90%), Frozen and Preserved Vegetables (0.49%), Sugar (1.57%), Other Food Products (0.57%), Coffee, Tea and Cocoa Products (1.08%), Soft Drinks (0.02%), Rum (1.00%), Wine (0.16%), Beer (0.44%), Cigarette (0.87%), Small tools and Accessories (0.13%), Non-durable Household Goods (0.78%) and Personal Care Products (0.37%).

Despite the overall increase, the groupings "Housing, Water, Electricity, Gas and Other Fuels" declined by (0.01%), "Health" (0.02%) and "Transport" by (0.35%), due to price decline in the following: Pharmaceutical Products (0.03%) and Motor Vehicle Fuel (2.02%). All the other groupings remained comparatively constant.

When compared to the corresponding month of last year May 2022, the Index moved from 114.72 index points to 118.34 index points in May 2023, recording an increase of 3.16%. This rise is attributed to increases in the following groupings: "Food and Non Alcoholic Beverages" (9.28%), "Alcoholic Beverages and Tobacco" (4.61%), "Clothing and Footwear" (0.92%), "Housing, Water, Electricity, Gas and Other Fuels" (0.89%), "Furnishing, Household Equipment and Routine Household Maintenance" (2.45%), "Health" (2.50%), "Transport" (2.47%), "Recreation and Culture" (0.53%), "Education" (1.78%), "Restaurants and Hotels" (13.62%) and "Miscellaneous Goods and Services" (1.27%). These increases resulted from rising prices of: Rice (2.28%), Breakfast Cereals and flour (7.00%), Bread (1.85%), Other Bakery Products (7.20%), Pasta Products (7.48%), Beef (1.56%), Pork (7.56%), Mutton (0.83%), Poultry (8.97%), Deli Meats (2.88%), Fresh Fish (21.17%), Preserved Fish (11.05%), Milk (6.66%), Cheese (8.34%), Butter (17.85%), Margarine (8.53%), Cooking Oil (7.49%), Fresh Fruits (2.68%), Preserved Fruits (2.26%), Fresh Vegetables (13.44%), Potatoes (9.43%), Frozen Vegetables (7.52%), Sugar (30.41%), Jams and Honey (1.39%), Ice Cream (16.86%), Other Food Products (7.96%), Coffee, Tea and Cocoa Products (15.47%), Mineral Water (1.92%), Soft Drinks and Concentrates (5.91%), Fruit Juices (4.69%), Rum (2.38%), Wine (10.13%), Beer (7.27%), Cigarettes (1.05%), Clothing Materials (10.34%), Men's Clothing (1.68%), Children's and Infant's Clothing (2.87%), Rent for Housing (1.39%), Materials for Repair and Maintenance of dwellings (3.72%), Electricity (3.03%), Household Textiles (1.48%), Glassware (3.46%), Small Tools (4.10%), Non-durable Household Goods (5.05%), Pharmaceutical Products (0.30%), Medical Services (8.32%), Motor Vehicle Fuel (3.95%), Repair and Maintenance of Motor Vehicles Services (0.31%), Passenger Transport Service by Air (15.45%), Books (3.10%), Pre-primary and Primary Education (3.12%), Tertiary Education (1.16%), Restaurant Services (13.62%), Personal Care Products (4.16%) and Social Protection Services (0.22%). The group "Communication" remained comparatively constant.

Consequently, the inflation rate for May 2023 is 3.16%, compared to a rate of 2.20% recorded in May 2022.
