**Re Grenada Parliamentary Elections Office: 2022 General Elections Results Summary  
Polling Station K09, NADMA Building, Richmond Hill**

Greetings to you and the staff of the Parliamentary Elections Office!

I write to you in **my personal, individual capacity**, as a citizen who recently voted in the 2022 General Elections which took place on June 23<sup>rd</sup>.

I recently became aware of the *2022 General Elections Results Summary* and had access to a hard copy. This report is also on the website of the Parliamentary Elections Office, at <http://elections2022.gd/>.

I am particularly interested in the results of **Polling Station K09**, located at the NADMA Building, Richmond Hill where I have cast my vote over the last four elections – 2008; 2013; 2018 and 2022. This year I decided to “test the system” and **this test yielded an unexpected result.**

**Results of Polling Division, K09:**

According to results on page 70 of the report, the results K09 Polling Station were as follows:-

• Clarence Gregory Bowen of NNP	83 votes
• Dennyka Checkley of GRP	1 vote
• Nicholas Bassanio of the IFP	3 votes
• Philip Alfred Telesford NDC	120 votes
• Rejected Ballots	0
• <b>Total Ballots Cast</b>	<b>216 ballots</b>
• Spoilt Ballots	0

**Where is this vote accounted for?**

- Based on the results, I observe that **my vote, apparently, is not accounted for in those results.** I can make this observation because my test of the system was to deliberately cast a vote that should/would be in the category “rejected ballots”.
- The category **Reject** does not reflect any votes cast; **0 votes**.
- A number of questions therefore arise:-
  - Was there a **typographical error** in the preparation of the summary report?
  - Was there a **counting error in respect of the ballots?**
  - Was my **ballot allocated in error to one of the other categories?**
